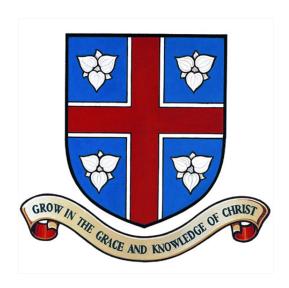

Minutes of Annual Vestry Meeting - February 7, 2016, 11:00 am

- 1. The Rev. Canon Rob Park offered an opening prayer and welcome.
- 2. Appointment of Vestry Clerk. Henriette Thompson was appointed.
- 3. Signing of Declaration. Circulated and completed.
- 4. Business Arising and Adoption of the Minutes of the Vestry held March 1, 2015. Reviewed and approved by Parish Council. Moved/second (M/S) that the minutes be adopted: Paul Skuriat, Jan Costain. Carried.
- Business arising from the 2015 minutes:
 - Emergency communications plan by Pam Soward. David Durant and Rick Gorski offered to gather information about the municipal emergency response plan, and with the Corporation, identify areas of alignment or gaps.
 - Heating and cooling system update. Property committee looking to make adjustments in various locations in the building, especially the radiators and piping. Updates as appropriate.
 - Sustainability partnership report. See Item 3, below, for discussion notes.
- 6. Rector's Report. Additional notes: Update on Georgetown District High School interest in St. George's parking lot and redevelopment. Discussions are quiet at the moment. The hope was that the partnership with the high school would involve a new parking lot.
- 7. The Norval, Stewarttown, and Hornby parish cluster has broken up. Some clergy transitions may lead to new possibilities.
- 8. Rob acknowledged, with thanks, Dan Gartenburg's leadership in the installation of the new heating and cooling system.

- All management reports were received with gratitude. M/S Mark Kohler, Janet Armstrong. Carried.
- 12. Reports from Parish Organizations and Acceptances
 - St. George's is now a Sustainability Champion of the Halton Hills Sustainability Partnership.
 - Rick Gorski acknowledged with gratitude contributions of many in the parish. Of the Sustainability Partnership's four pillars, Vibrancy and Social Wellbeing are strengths of St. George's. A Sustainability Champion endorses the Town's plan plus provides active leadership and participation.
 - St. George's is the first church to be named as a Champion. There are 25 programs at St. George's with 11,000 volunteer

hours annually. We partner with five other community programs (such as Fresh Food Box). There are four community programs where we provide facilities and volunteers. Seven community groups use our facilities (such as Camera Club, Horticulture Society) for a small fee, with 2000 hours of use.

Benefits to St. George's include a reference on the Town website of our community events such as the Christmas bazaar, and possible access to funding for community projects.

Rick Gorski and Jan Lehman will continue to give leadership. Volunteers and ideas are welcome!Rev. Rob thanked all groups for their reports reflecting the effective effort and outreach of the parish in the community.

M/S that all the reports be accepted: Pat Durant and Helen Vandermey. Carried.

13. Elections and appointments

- Election of People's Warden. Thanks were offered to Paul Skuriat for his service in the past year. Paul agreed to allow his name to stand for re-election. Nominations opened from the floor. M/S that nominations be closed: Jan Costain, Charles Clifford. Carried, By acclamation.
- Appointment of Deputy Rector's Warden. Mark Kohler has agreed to a re-appointment. We thanked Mark.
- Election of Deputy People's Warden. Jan Lehman has allowed her name to stand for re-election. No nominations from the floor. M/S that nominations be closed: Ian Oldaker, Wendy Lovely. Carried.
- Delegates to Synod 2016-2017 Two-year term. Elections in even-numbered years. All four are willing to stand for reelection -- Pat Durant, Wendy Lovely, . M/S that nominations be closed: D'Arcy Keene, Jean Lorriman. Carried.
- Alternate Delegates to Synod 2016-2017: Helen Shannon, Janet. McFarlane M/S that nominations be closed: Janet Armstrong, Jenny Tuffin. Carried.
- Election of Youth Delegate to Synod for 2016. In spite of efforts of the Nomination Committee, there are no delegates to nominate at this time.
- Election of Delegates to Youth Synod for 2016.
 One-year term; we can send up to three delegates. M/S that nominations be closed: Doug Penrice and Joanna Alchin.
 Emily Laws acclaimed. Carried.
- Election and Appointment of Members of Parish Council.
 M/S that nominations be closed: Yvonne Oldaker, Audrey Houston. Carried. Meetings will be held 4 times a year on the third Monday of the month.

The Reports

Report of the Rector

This year's report from the rector reflects both the challenges and blessing of 2016 at St. George's.

Indeed, 2016 brought some significant challenges.

The year started with 8 funerals in the first four months, including the tragic death of Zach Sutherland. It is with great faith that we commit our loved ones to God's keeping and it is with the love and compassion as a community that we support and uphold those who grieve with our prayers and with our presence. I am grateful for the pastoral care and outpouring of compassion that demonstrated how we, as a church, are ready stand with and support those who grieve even as we grieve ourselves.

Musically, we have faced some further challenges. It was our hope to have been able to hire a music director this year, but the financial resources have not permitted this. That said, I am truly grateful that in 2016 we were blessed by the commitment of the choir and the 11:15 music team. We also had support from Darlene Hammond, who volunteered to help the choir with a number of anthems, and from Chris Dawes, who as an organist supply prepared the choir and played at Easter, Pentecost, and Christmas.

After the overwhelming support shown financially to replace the heating system in 2015, our hope was to focus on general stewardship and support for our ongoing ministry. It was our intention to be build up our base of regular financial support to allow us to be in a position to hire a music director to replace Ron Greidanus. I am grateful to those that were able to respond positively to this year's stewardship campaign, but overall we were unable to gain ground. This was due to the unexpected loss of support from folks who moved or passed away. With our hard work and the dedicated support from so many good people and families here at St. George's, being unable to move ahead and seek a replacement for music director, has been a disappointment.

2016 also was a year where we, despite these challenges, continued to proclaim the Good News of Jesus Christ in word and deed.

I am extremely proud of the volunteer commitment of the people of this community and the good work that the gifts of time and talent offered by so many good folk. As a church we continue to offer over 11,000 hours of volunteer time to enable worship and to do good works. Our Worship is supported by mesh of volunteers, from the Altar Guild behind the scenes to the faces you see up front on Sunday reading, praying, serving, and singing. Our work in the wider community is given form by the teams of volunteers who help with the Fresh Food Box, The Walk for ALS, the summer Kid's Camp program, and Messy Church.

I am thankful for the continued leadership of Ian Oldaker, Paul Skuriat, Mark Kohler, and Jan Lehman as church wardens, and Brenda Sisnett as treasurer. They are caring, kind, and wise in demonstrating their leadership and show respect for the trust you and I have given them in these roles.

I am grateful for the ministry of The Rev'd Nancy Rowe and her ministry with our church families, through baptism, the First Step's program, Church School, and Messy Church. Her leadership and care has help build a network of care that extends our reach and expresses the joy of Christ to our youngest members and their parents.

I also greatly appreciative of the support, presence, and work of Sue Graham in the church office and other administrative duties. Her experience and her long standing relationships with so many church members make her presence irreplaceable.

In 2017, we will need to grow monthly support of ministry if we are to be able to consider hiring a replacement for the important position of music director. This will be a big boost to the 9:30 choir and the 11:15 music team, and our music ministry in general.

In 2017, there are some important property projects to tackle which are highlighted in our hardworking Property Committee's report.

Most importantly, in 2017, I pray that we will continue to proclaim the Good News of Jesus Christ both through our many faceted ministry as a parish family, but also in each of the lives of our parish members. Through the power of the Holy Spirit, we may together reflect that Good News to our neighbours, families, and co-workers.

Report of the Wardens

St. Georges continues to be home to a vibrant community of Anglican worship in Georgetown. The Wardens would like to once again thank Rev. Canon Rob Park and Rev. Nancy Rowe for their leadership, dedication and sharing of their considerable talents with all who interact with them.

In 2016, St. Georges was fortunate to receive a few one-time gifts from parishioners that lessened the financial challenges for the year. We are grateful for these donations as they have helped us make up for prior year's deficits. While these gifts have helped in 2016, they are not expected to recur in 2017. As a result, stewardship efforts continue, and it is the hope of the Management Committee that more people will sign up for Pre-authorized giving and those who are already signed up to offer a small increase for this year. Other stewardship initiatives are being considered.

Annual budgeting is a complicated process and to keep our expenses to a minimum we had to creatively manage our music and cleaning programs again this year. We note that the cost of natural gas last year was substantially lower than previous years, we believe in part because of the increased efficiency of the new heating system boilers.

Rob continues to look after selecting hymns and worship music for Sunday services as well as coordinating and meeting Ron Greidanus to record hymn music as needed. Chris Dawes was also asked to play "live" for special occasions including Easter and Christmas Eve, and Ron Greidanus also made a quest appearance at the 5:00pm Service on Christmas eve.

We were very pleased to see an augmented choir for Christmas and other services at which anthems were sung. Can we encourage more parishioners to join the 9:30 choir? It is a wonderful contribution to the worship at St. George's church.

We continue to benefit from steady renters of our facilities with occasional events such as baby showers and receptions. We even have a small group using the church twice a month for a fiddle jam session. The wardens like to encourage reaching out to the community by all parishioners and spreading the word about St. Georges through these users.

The wardens also wish to thank all involved for their time and efforts to keep the church, buildings, and grounds clean and tidy. Efforts of these volunteers make St. Georges pleasant for all who visit us.

We would also like to extend a big thank you to all the helpers who organized and made the annual bazaar a great success. 2016 was another record year with revenues less expenses of approximately \$12,500. Special thanks go to Jan Lehman who led the efforts and all those parishioners who worked tirelessly leading up to the bazaar and on the day itself, they deserve our heartfelt thanks for all the work to organize and carry out this annual event. It continues to be a highlight of the year for many people in the local community.

Finally, the wardens would like to acknowledge and celebrate the success of the many parish groups who contribute to the mission and ministry of St. Georges. We are encouraged by these groups who help sustain our church community and make St. George's a great place to be!

Music Ministry

With the 9:30 Choir, in 2016 we were blessed to have had volunteers, like Bruce Ott, step forward to help with some of the leadership for the first part of the year until Easter. We have had the talented Chris Dawes provide leadership for special services at Easter, Pentecost, and Christmas. Weekly, the choir and congregation has continued to rely on the pre-recorded hymns. It was with sadness that we unexpectedly had to say goodbye to Bruce Ott and Henriette Thompson, who both moved during the year to be closer to their children and grandchildren. In the light of these major challenges, the 9:30 choir has worked hard to provide leadership and joy through hymns and anthems during the year. St. George's has been blessed by their dedication.

The 11:15 music team, has also faced some transitions and challenges. Some existing volunteers have needed to step back in their commitment and, yet fortunately by God's grace, some new volunteers have stepped forward. Without the consistency of a music director, this has been a much bigger transition, and additional adjustments have had to be made to the music at the 11:15 service. Again, St. George's has been blessed by the musical leadership provided by the 11:15 music team.

We are blessed to have such an offering of different musical styles, and great volunteers who help make it happen. And these volunteers are grateful for the continuing support of the parish, especially during this challenging time without a dedicated music director.

First Steps & Next Steps Program

There were 10 Baptisms this year and these families have joined the First Steps Program. There are 25 families on the First Steps program which runs from Baptism until 4 years of age. The First Steps Program includes a letter once a month outlining upcoming events at St. George's as well as a reflection on the theme for that month's Messy Church. It also includes an age specific "Splash" page that has parenting tips and ideas on how to nurture the faith of your child. I call each family once a month to say hi and to catch up on any family news. It is nice to touch base on a regular basis. At age 4 the child becomes part of the Next Steps program. On the Next Step program the First Steps newsletter and reflection piece is sent out electronically to the families.

Fundscrip

Fundscrip is a program designed to provide St. George's with income without any cost to members. Gift cards can be bought every month for regular as well as gift purposes. Retailers give 2% to 10% of sales back to our church.

Participating retailers include grocery stores, restaurants, clothing, health and specialty shops, and home and hardware stores.

In 2016 Fundscrip income was \$1980.75. Since the program started in May 2013, St. George's has received an income of \$6905.25. Average number of participants per month this year has been 13. With orders over \$7000 the shipping charges of \$12.98 are waived. We succeeded in reaching this goal in August and December of this year.

Property Committee

2016 was somewhat of a quieter year for the Property Committee, but only insofar as not having to complete any major capital projects. Other smaller projects completed this past year include:

- Replacement of aging smoke detectors throughout the building.
- Emergency repairs to the main entrance door which had fallen off its hinges.
- Replacement of most of the exterior light fixtures with new LED fixtures.
- Interior lighting maintenance emergency lighting, projector bulbs, florescent bulbs and ballasts, spot light replacement etc.
- Adjustments to the heating system to help allow the new boilers to better maintain comfortable temperatures in the church.

Existing smoke detectors had previously been identified as being in need of replacement during one of the regular fire safety inspections. The smoke detectors were replaced and have an expected lifespan of roughly 10 years.

Emergency repairs were conducted on the main entrance door as it had partly detached from its hinge mounting. A new hinge assembly was installed to re-secure the door to the aluminum frame.

A number of adjustments have been made to the operation of the heating system in an effort to help maintain more consistent temperatures, particularly in the church area itself. The adjustments are with the heating water distribution system, and not with the boilers themselves, which are working very well. The installation of the new boilers in 2015 has highlighted some issues with the existing distribution piping that makes it more difficult to maintain the intended flow of hot water where and when it is required. We are currently looking at options and their associated costs for helping improve this situation, which would likely include some modifications to the heating water piping in the ceiling space of the basement area.

Many other small, medium, and larger size projects remain on the horizon for the property committee, some of which may require special fundraising efforts. These include:

- Plaster and structural repairs around the triangular window above the altar.
- Levelling of the depression in the hall floor.
- Relocation or reconstruction of a new outdoor storage shed.
- Re-grading and other surface improvements to the parking lot.
- Repair of the exterior stairs and landing leading to the door of Rob's old office.
- Replacement and reconfiguring of the eavestroughs to better capture rain water from the roof.

Reconfiguration of the eavestroughs is necessary to prevent a large portion of rain water from washing over the eavestroughs and landing on the ground beside the foundation walls where it causes water issues inside the building. This will involve some carpentry work in addition to new eavestroughs as the structure of the roof area around the facia needs to be modified to accommodate the new location of the eavestroughs.

The Property Committee would like to thank Jeremy Brown and Mike Walton for keeping the church lawn cut, trimmed, and looking great throughout the summer months. We are also appreciative of all other help we receive with the ongoing property maintenance throughout the year, including both at scheduled work days and at the many other times in between. We look forward to seeing you again in 2017.

St George's Sustainability Partnership Program

St. George's renewed its commitment as a Sustainability Champion partner in our community in December 2016. Thank you to all our volunteers who contribute their time, energy and resources to our various ministries, programs and community events and partners. Thank you also to the program coordinators supporting the annual survey with your input.

This program raises the awareness in our Church of the opportunities for volunteering, coordinating our actions with other community agencies, and acknowledges our leadership in the community.

The St. George's community at large continues to be a very significant contributor to a sustainable environment through its volunteers and facilities which support all four goals of the Town, particularly in the Social Wellbeing and Cultural Vibrancy areas. The Town acknowledges that the Church and hall provide a place of worship and provides well supported planned functions and activities. The maintenance of the Church and hall is recognized as well. By offering space at the Church and hall to the community we are expanding our sustainability in the community and demonstrating that in partnership we can accomplish much more together than alone.

Here are the some of the highlights from our survey documentation:

St. George's identifies with 43 programs where Church members volunteer an estimated 10,800 hours each year, and Church facilities are used for 2,500 hours annually (this excludes worship services).

This is the breakdown:

- 23 St. George's programs contribute a total of 9,200 volunteer hours annually to the community.
- 6 partner programs where St. George's volunteers are involved for 360 hours annually.
- 5 community programs where St. George's provides volunteers for 1,200 hours each year and donates facilities for 960 hours per year.
- 7 community groups are provided with the use of St. George's safe, clean, comfortable & accessible facilities at a nominal cost for 1,550 hours per year.

St. George's also partnered with the Town of Halton Hills in March to host a community stargazing event during Earth Hour. We had the support of the 2nd Georgetown Scout Troop & Leaders, parish volunteers, Cosmic Connections for the presentation & stargazing experience, and Halton Hills Hydro for their sponsorship of the event & energy conservation awareness information.

This past December, we also partnered with the Salvation Army Community Church for their Christmas Assistance Program by collecting donations of new toys, games, books, crafts, hoodies for the teens, makeup and cosmetics, and cash donations to be used toward food gift cards. Even some leftover items from our Bazaar were donated to this program.

St. George's was also a successful applicant for funding from the Town of Halton Hills Community Sustainability Investment Fund to construct two permanent wooden donation boxes for the Georgetown Breadbasket, Links2Care Holiday Giving, and the Salvation Army Christmas Assistance Programs. The efforts of John Reaume in the specification and design, acquisition of materials, construction, finishing and delivery of our donation boxes is acknowledged and greatly appreciated.

The information and data gathered for this program is maintained and updated annually and used as a Church administrative tool. It provides useful information for planning, budgeting, coordination of resources, identifying strengths and areas for improvement.

Thank you all for every contribution you have made to our community at large and at St. George's which demonstrates we are building a community of caring and compassion in our town.

St George's Anglican Men's Club

May 25 – Jamaican theme: jerk chicken and ribs.

June 22 - BBQ: burgers and sausages.

November 23 – Cooking with Eggs theme: appetizers and omelettes.

The gatherings provide opportunities for fun, fellowship and camaraderie in a relaxed social atmosphere. There is plenty of informal conversation on any number of topics. The discussions are light, enlightening and entertaining. It is a great opportunity to share with and to better know our fellow parishioners and community guests.

We enjoy a three course dinner prepared by club members who volunteer their cooking skills. 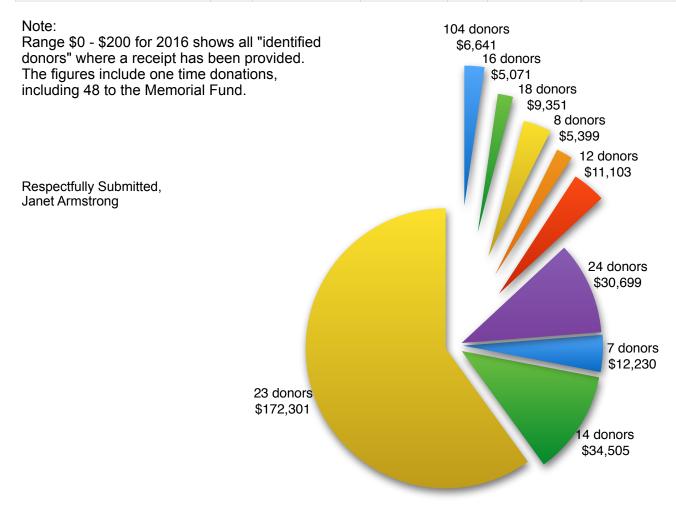

Motions and New Business

Annual Motion to authorize Corporation to enter into agreements with non-parish groups regarding the use of Church property

The Anglican Church of Canada Act (1979) is the Provincial statute that defines the powers of incumbents, wardens, synods, and bishops in property matters. The Act states that church properties may not be leased or encumbered without the consent of the vestry, the synod, and the bishop.

In order to comply with the Anglican Church of Canada Act and new canon 4.7, **vestries need to pass this motion** authorizing the incumbent and wardens to enter into agreements with non-parish groups regarding the use of church property.

BE IT RESOLVED

That the Vestry of St. George's Church authorized the Incumbent and Churchwardens to consider and, if they deem it advisable, to approve leases, licenses, or space agreements of less than three years inclusive of all renewals.

That this authorization shall only extend to agreements that include the following provisions:

the agreement may be terminated by St. George's Church upon thirty days notice

the lessee or licensee agrees to abide by the Diocese of Niagara's sexual abuse policy

the lessee or licensee will provide proof of liability insurance.

the lessee of licensee agrees to hold harmless St. George's Church, the Synod of the Diocese of Niagara, the Bishop of Niagara, and the Anglican Church of Canada

And that, if there is any conflict between this resolution and any authorization or approval resulting from it and the Canons of the diocese of Niagara, it is understood that the Canons shall prevail.
